



EMERGENCY MEASURES COVID-19: **Driving and vehicles**

Barcelona, 24 March 2020

SUMMARY

We summarise below the measures adopted for driving and vehicles related to administrative driving authorisations, validity of driving licences and complaints regarding compliance with deadlines, in accordance with the Order of the Ministry of the Interior INT/262/2020 of 20 March published in the Official State Gazette on 21 March 2020.

ADMINISTRATIVE AUTHORISATIONS FOR DRIVING AND CONCERNING VEHICLES

The Order of the Ministry of the Interior INT/262/2020 of 20 March, published in the Official State Gazette on **21 March 2020**, the **date of its entry into force**, approved the following in relation to administrative authorisations for driving and vehicles:

^ NATIONAL ADMINISTRATIVE DRIVING AUTHORISATIONS

Over the duration of the state of emergency and its successive extensions and **up to 60 days after it terminates, the validity of permits and driving licences**, as well as other administrative driving authorisations whose **period of validity expires during the state of emergency** and extensions thereto **is extended**.

^ VALID AND CURRENT FOREIGN DRIVING LICENCE

Over the duration of the state of emergency and its successive extensions, **the 6-month period** during which the holder of a foreign driving licence valid for driving in Spain may drive in national territory is **interrupted**. The calculation of the period will be resumed as soon as the state of emergency and its extensions cease to apply.

A ADMINISTRATIVE AUTHORISATIONS CONCERNING VEHICLES

Over the duration of the state of emergency and its successive extensions and **up to 60 days** after it terminates, **the validity of the temporary authorisations** regulated in Articles 42 et seq. of the General Vehicle Regulations is **extended**.

A COMPLAINTS CONCERNING INFRACTIONS RELATED TO THE FULFILMENT OF THESE DEADLINES

Over the duration of the state of emergency and its successive extensions **no complaints will be brought** relating to compliance with the above-mentioned periods and time-limits.

We will continue to inform you of any new measures that may arise as a result of the COVID-19 pandemic.
